■ MANUFACTURE

This Reference Product comes from sites that have received ISO14001 certification.



■ DISTRIBUTION

Products are distributed from logistics centres located with a view to optimize transport efficiency. The Reference Product is therefore transported over an average distance of 780 km by road from our warehouse to the local point of distribution into the market in Europe

Packaging is compliant with european directive 2004/12/EC concerning packaging and packaging waste. At the packaging end of life, its recyclability rate is of 93% (in % of the mass of the packaging)



■ INSTALLATION

■ USE

Servicing and maintenance:

END OF LIFE

Development teams integrate product end-of-life factors in the design phase. Dismantling and sorting of components or materials is made as easy as possible with a view to recycling or failing that, another form of reuse.

• **Recyclability rate:**

Calculated using the method given in technical report IEC/TR 62635, the recyclability rate of the product is estimated at 89% the effective use of the channel for electrical and electronic products at the end of their life.

Separated into:

- plastic materials (excluding packaging) : 69%
- metal materials (excluding packaging) : 10%
- other materials (excluding packaging) : 0 %
- packaging (all types of materials) : 10%



ENVIRONMENTAL IMPACTS
